During the financial year ended 31 March 2021, this authority's internal auditor acting independently and on the basis of an assessment of risk, carried out a selective assessment of compliance with the relevant procedures and controls in operation and obtained appropriate evidence from the authority.

The internal audit for 2020/21 has been carried out in accordance with this authority's needs and planned coverage. On the basis of the findings in the areas examined, the internal audit conclusions are summarised in this table. LINE B - The Council's Standing Order 19 - "All payments by the Council shall be authorised, approved and paid in accordance with the law, proper practices and the Council's financial regulations."

The Council's Financial Regulations - "All payments will be considered at a meeting of the Parish Council. Details of all payments will be shown in the Minutes of the Meeting."

All payments were supported by invoices as required. However not all payments were authorised at the appropriate time with many only approved retrospectively. This was caused mainly by problems associated with Covid regulations and the difficulty caused by virtual meetings. The Council has addressed this problem and there is no indication of any ~~or~~ unauthorised payments. Therefore the "YES" column has been ticked on Line B.

LINE D - The precept for 2020/21 was considered and approved at a Council meeting on 15th January 2020 and minuted accordingly. However it was only recorded as a 3% increase on 2019/20 and no exact figure was quoted.

It is recommended that the Council states an exact figure for the precept in future years.
